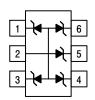

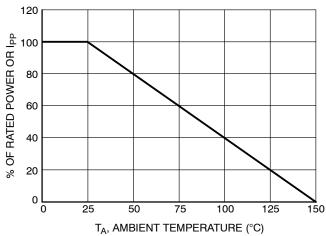


Figure 1. Power Derating vs. Ambient
Temperature

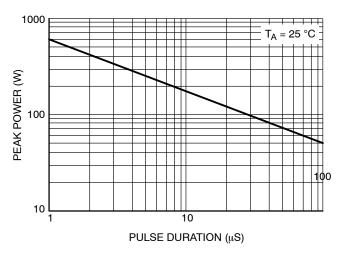


Figure 2. Peak Power vs. Pulse Duration

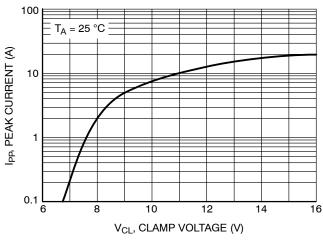


Figure 3. Peak Current vs. Clamp Voltage

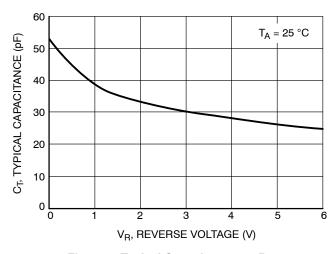


Figure 4. Typical Capacitance vs. Reverse Voltage

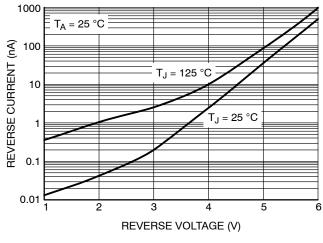


Figure 5. Reverse Current vs. Reverse Voltage

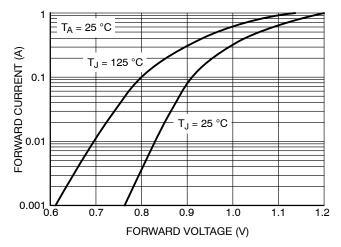


Figure 6. Typical Forward Current vs. Forward Voltage



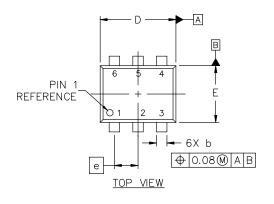


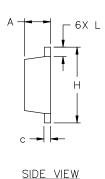

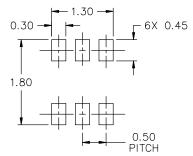
