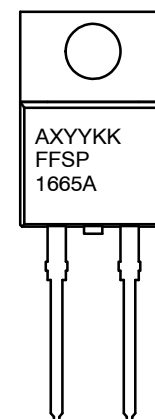

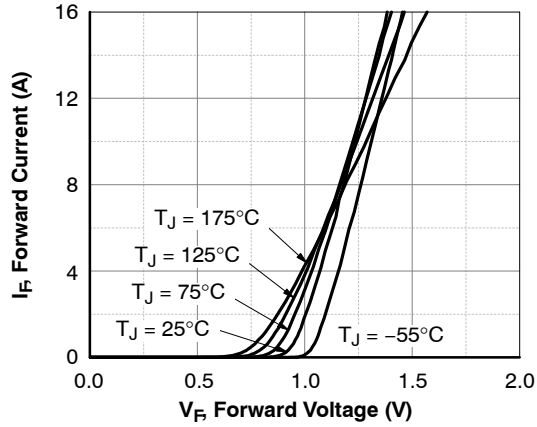


Figure 1. Forward Characteristics

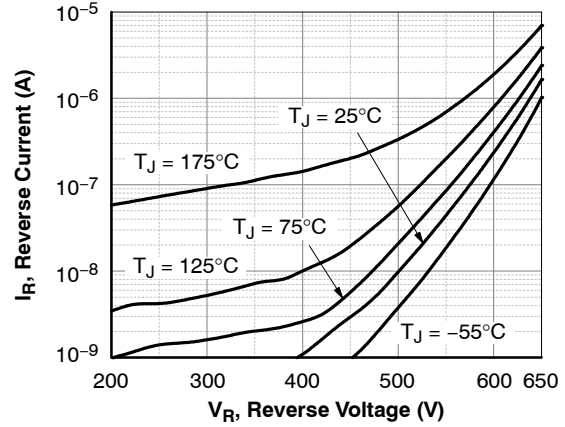


Figure 2. Reverse Characteristics

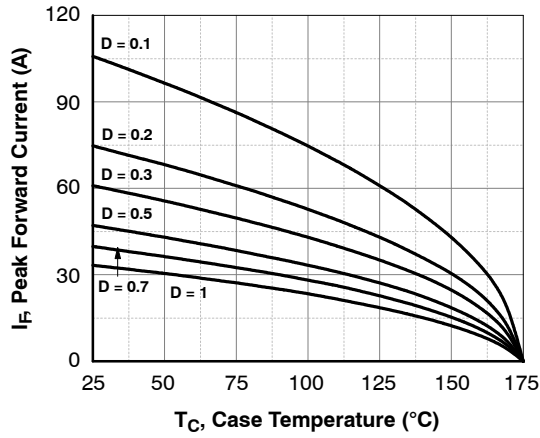


Figure 3. Current Derating

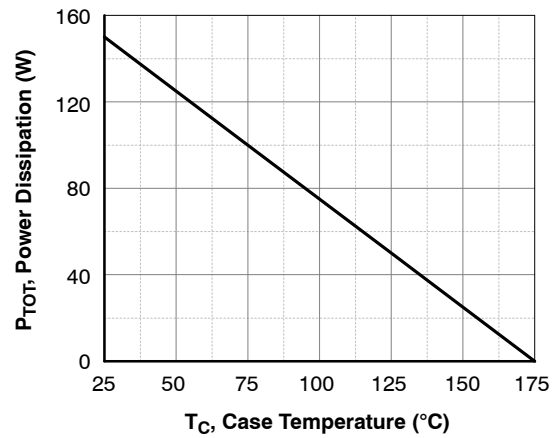


Figure 4. Power Derating

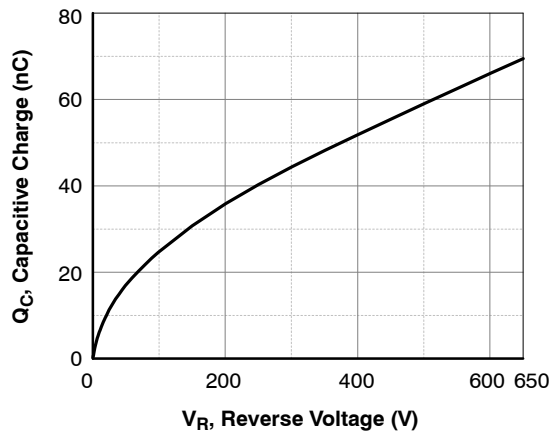


Figure 5. Capacitive Charge vs. Reverse Voltage

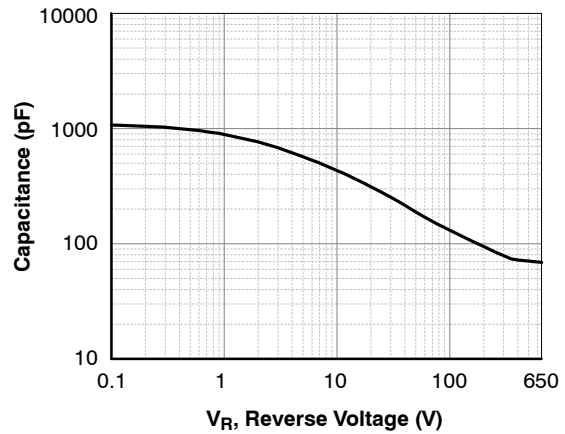
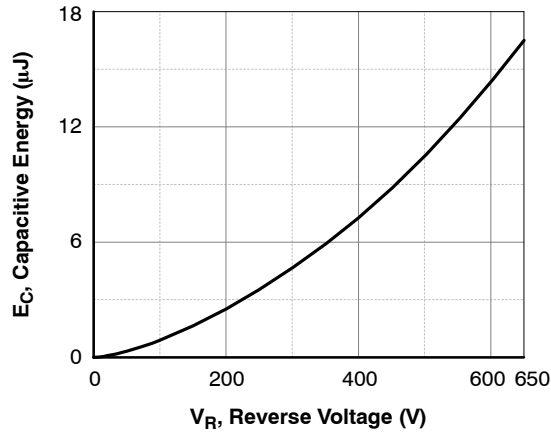


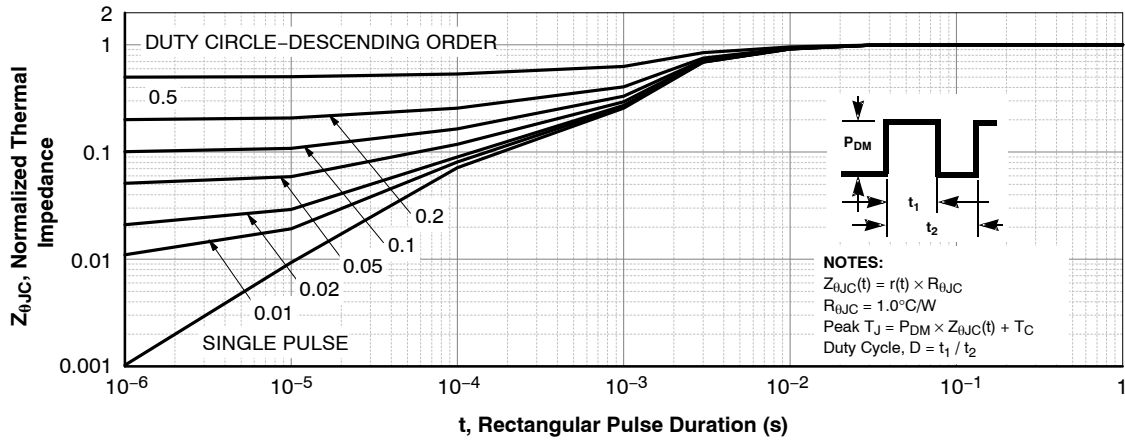
Figure 6. Capacitance vs. Reverse Voltage

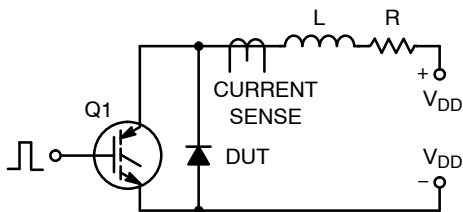
**Figure 7. Capacitance Stored Energy**

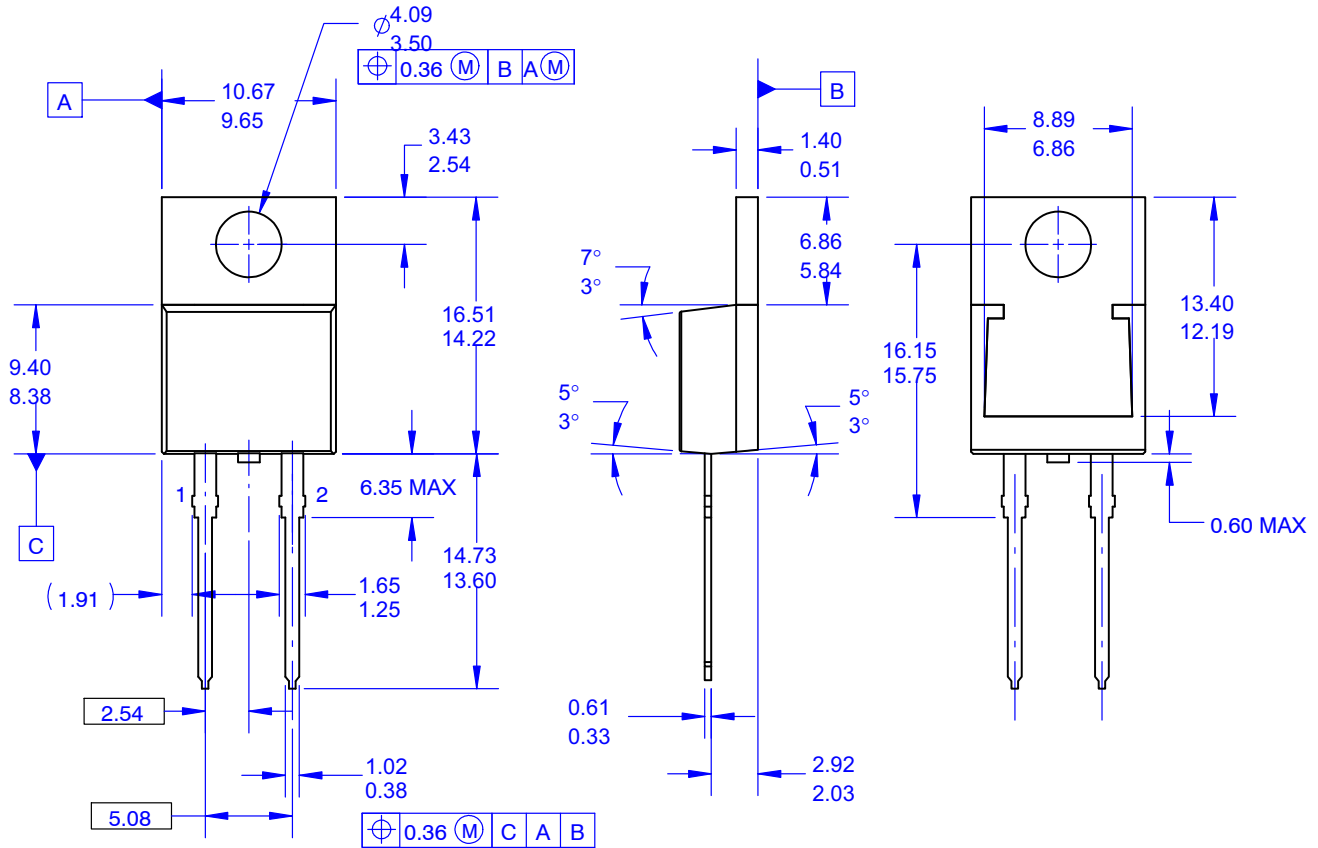

**Figure 9. Unclamped Inductive Switching Test Circuit & Waveform**

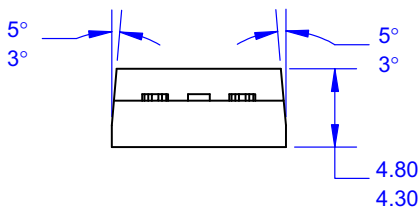
